Executive Summary

Solutions That Empower People, Inc. or "STEP" has been the designated community action agency responsible for carrying out anti-poverty work in Franklin and Patrick counties of Virginia since 1966. It is our Mission to work with our community partners to facilitate solutions that empower people to overcome their barriers to economic, educational and developmental success. With this objective in mind, and as the needs of these communities have changed and new opportunities became available, STEP has evolved to meet those needs through an array of programs and services that focus on early childhood education (Early Head Start and Head Start); youth services (LIFES Academy and Project Discovery); senior services (Meals on Wheels, transportation); supportive services (re-entry, homelessness prevention); housing services (rental assistance and weatherization); and financial services (tax preparation assistance). In addition to the mandated service areas of Franklin and Patrick counties, STEP provides certain programs and services in the counties of Bedford, Henry, and Pittsylvania as well as in the cities of Martinsville and Danville. STEP has an annual budget of \$4.7 million; has about 100 employees; is assisted by more than 200 volunteers; and serves more than 3,400 people annually.

Every three years STEP conducts a comprehensive community needs assessment to identify the root causes of poverty in our community. The results of this study set the criteria and priorities for determining the most effective means of utilizing the resources entrusted to us in order to help our clients break the bonds of poverty and build a better life for themselves and their families, sustainably.

We would like to thank everyone who participated in this study including all of the survey and interview participants, our staff, our Board of Directors, and our community collaborators for their commitment and goodwill throughout this undertaking.

Assessment and Planning Process

Steering Committee

A Steering Committee consisting of the Executive Committee of the Board of Directors and the Executive Director was formed in the summer of 2017. The Steering Committee went about its work with input from all STEP program directors. The Steering Committee met several times and was responsible for:

- Providing leadership, direction and oversight of the community needs assessment and strategic planning processes.
- Ensuring that stakeholders and a robust cross section of community and low-income representatives were given the opportunity to articulate the needs that they have experienced or observed and participate in the process of establishing related goals, objectives, and strategies for meeting or overcoming them.
- Establishing timelines for the completion of tasks.
- Analyzing the critical issues identified by the needs assessment surveys and interviews.
- Making recommendations to the Board of Directors regarding priorities, goals and objectives, necessary resources, comprehensive operational strategies, intended outcomes and measurements for evaluating overall effectiveness.
- Ensuring the goals and strategies presented to the Board of Directors are consistent with the agency's vision, mission and values, and address the needs of the community as effectively, efficiently and holistically as possible.
- Ensuring these processes and outcomes are consistent with the expectations of the Virginia Office of Volunteerism and Community Services, the requirements of the Community Services Block Grant (CSBG) Act, the National Community Action Network Theory of Change which guides all Community Action activities, and follows the format and principles of the Results Oriented Management and Accountability (ROMA) system.

The strategic planning process was facilitated by Monica Jefferson of the Virginia Housing Development Authority.

These losses, not uncommon to rural communities, stem from economic recession, increased competition, and the shifting of manufacturing jobs overseas.

The preceding chart shows the levels of children that live in poverty in STEP's service area. Franklin is the only county that has significantly decreased the number of children living in poverty over the last few years. Poverty rates among children in Henry and Patrick counties and the City of Martinsville are essentially stagnant at about twice the state average. Poverty has a profound impact on children. Studies show that nearly 30% of children in poverty do not complete high school (Urban Institute), have increased incidents of psychiatric disorders, reduced levels of social and academic functioning, and a higher likelihood of chronic physical health problems (Child Fund International).

The percentage of families living in poverty is exponentially greater in single parent households than married-couple families. According to the U.S. Census Bureau, in 2017, out of about 12 million single parent families with children under the age of 18, more than 80% were headed by single mothers. STEP's service area has a higher rate of families in poverty under each living situation than the state average.

Housing by Service Areas

STEP produces an annual Point In Time (PIT) Survey for Franklin, Patrick, and Henry counties to collect primary data on homelessness. This data is only collected one day per year. It can be very difficult to obtain an accurate count but it allows a snapshot of the challenge at a given time.

HUD defines cost-burdened families as those "who pay more than 30 percent of their income for housing." The percentage of cost burdened households in STEP's service area is lower than the state and national averages. Franklin County has the highest rate of households experiencing housing cost burden. Affordable housing frees up income for other expenses such as childcare, food, and the like. Additionally, the number of seniors with mortgages has increased throughout the state (U.S. Department of Housing and Urban Development).

A public housing program has been established by the United States government to provide housing for low-income families, disabled persons, and the elderly. These individuals or families must meet certain eligibility requirements to participate in the program and may be required to pay a nominal amount of rent. All of the public housing in STEP's service area is full which is indicative of the demand exceeding the supply.

While the number of Section 8 rental assistance vouchers that STEP is authorized to fund and administer annually ebbs and flows based on available funding, STEP currently administers about 190 (collectively) in Franklin and Patrick counties. The window to apply for this assistance typically only opens about every four to five years (for about four hours at a time) therefore securing this aid can be a challenge. Currently STEP has 192 additional families on a waiting list for service.

The U.S. Department of Energy (DOE) Weatherization Assistance Program reduces energy costs for low-income households by increasing the energy efficiency of their homes, while ensuring their health and safety. Through weatherization improvements and upgrades funded by the DOE (with supplemental funding provided by the Low Income Energy Assistance Program (LIHEAP) and American Electric Power (AEP), these households save an average of \$283 a year according to a national evaluation of the program. These funds can then be reallocated to pay for other critical living expenses. STEP has received regular increases in funding for its Weatherization program. Current funding levels allow for the upgrading of about 50 homes annually (a significant increase over the 2017 funding shown above).

PALS-K is a measure of children's knowledge of several important literacy fundamentals. PALS-K provides a direct means of matching literacy instruction to specific literacy needs and provides a means of identifying those children who are relatively behind in their acquisition of these fundamental literacy skills. The data indicates that the number of children in STEP's service area that are not prepared to enter Kindergarten far exceeds the state average.

The Virginia Preschool Initiative (VPI) provides state funds to schools and community-based organizations to provide quality preschool programs for at-risk four-year-olds unserved by the federal Head Start program. The purpose of the grant is to reduce disparities among young children upon formal school entry and to reduce or eliminate those risk factors that lead to early academic failure. Related research shows that people who have participated in VPI as children are less likely to be held back in school, require fewer special-education placements, have higher graduation rates, experience lower crime and unemployment rates, have less reliance on welfare, and enjoy higher lifetime wages.

Head Start and Early Head Start

Head Start programs promote school readiness of children from birth to age five from low-income families by supporting their development in a comprehensive way. These programs provide comprehensive early childhood education, health, nutrition, and parent involvement services. Early Head Start (EHS) serves infants and toddlers under the age of 3, and pregnant women. EHS provides intensive comprehensive child development and family support services.

The majority of children enrolled in K-12 in STEP's service area attend public schools. It is noteworthy that in Patrick and Henry counties, that percentage is particularly high. The federal Volunteer Income Tax Assistance (VITA) program ensures that poor families have access to the Earned Income Tax Credit (EITC) and the Child Tax Credit (CTC), two tax provisions that target low- and moderate-income taxpayers. Both the EITC and the CTC significantly reduce taxes on low- and middle-income families with children. Adding the amount of the EITC and CTC to family income reduced the number of people in poverty by almost six million in 2011 (Hotz and Scholz 2003; Eissa and Hoynes 2006a; and Meyer 2010). Over half of the individuals moved above the poverty threshold were children. STEP manages the VITA program in Franklin and Patrick counties. Last year, STEP prepared 507 Federal returns. Of those, 181 were eligible for the EITC and 35 were eligible for the CTC. The average credits for the EITC and CTC were \$552 and \$678, respectively.

STEP Head Start & Early Head Start

Research conducted by the Brookings Institute shows that measures of social, emotional and behavioral development increase among children who participate in a Head Start program, resulting in greater self-control and self-esteem. That research also concludes that Head Start families tend to invest more in their own children years after their participation. Parents read more to their children; teach them about numbers, colors, and shapes while at home and engage more in conversation, increasing vocabulary and language skills, and fostering greater independence. Additionally, these same parents tend to spend more time with their children in positive activities. Participation in Head Start and Early Head Start programs (HS/EHS) has also been shown to improve post preschool outcomes, including increased high school graduation, college attendance, and college graduation rates when compared to students who did not participate in a school readiness program.

Prenatal support and educational services for pregnant women, childhood development, and school readiness services are available to eligible families through STEP's E/HS programs. We also provide some home-based programs. STEP enrolls more than 200 children (infant up to age 5) in our HS/EHS programs each year.

There are only four licensed and registered childcare programs serving children under four years of age in STEP's primary service area and only two of them provide subsidies for low-income families. Correspondingly, the children of these families are at a tremendous disadvantage in terms of accessing programs that support comprehensive child development. STEP's EHS program provides low-income children with comprehensive child development support. This includes health and nutrition programs that enhance their ability to learn so they are prepared for their educational careers. STEP's family-driven philosophy empowers parents to support and nurture their children while meeting other critical social and economic goals. STEP EHS enrolls 80 children each year. It is noteworthy that Henry County does not currently have an Early Head Start program.

STEP's HS program provides a comprehensive education for three and four-year-old children that encourages parental involvement and is designed to foster healthy development and school readiness. STEP provides education, nutritious meals, and the opportunity for social, emotional, and intellectual growth that helps prepare the children for success in school and in life. Medical and dental support services are also offered. The Head Start approach serves the entire family and seeks to empower both parent and child. STEP HS enrolls 138 children each year. The Head Start program in Henry County is operated by Pittsylvania County Community Action.



Community Identified Needs

The Steering Committee oversaw the collection, synthesis and analysis of the data collection process and ensured that respondents included adult program participants, parents of Head Start, Early Head Start and LIFES Academy students, taxpayers using VITA services, community organizations, community leaders, other community service agencies and their directors, as well as a broad range of area residents.

Primary Data Collection

Surveys

The survey design was based on versions used during the last two triennial strategic planning processes. As many of the questions as possible from prior years were retained in order to enable comparisons with past results. The surveys were formatted to eliminate leading questions and questions which could skew the participants' responses and were made available in English and in Spanish. Surveys were collected at 44 locations and on-line and generated 840 responses.

Stakeholder Interviews

Stakeholder interviews were conducted as one-on-one discussions with colleagues in other community service organizations, social services, education, healthcare, faith communities and local government. Participants were asked to identify the most critical unmet needs of low-income individuals in STEP's service areas. The interview questions required narrative answers and allowed for direct follow up questions aimed at identifying root causes of the problems identified and obstacles to overcoming them. A total of 62 agencies participated in this process. Respondents had a wide variety of affiliations that well represented the social fabric of this community.

Focus Groups

STEP was extremely fortunate to partner with Carilion Clinic for the purposes of conducting focus groups. Carilion has trained staff whose primary responsibility is organizing, executing and interpreting focus groups. A total of 16 focus groups were convened.

Other Community Needs Assessments

Several of STEP'S community partners who have recently completed their own needs assessments were generous in sharing their reports. This provided STEP with critical data as well as a means of comparing and evaluating indicators and conclusions within the broader scope of this region. Their partnership allowed STEP to compare trends, and to learn from their experiences in terms of setting goals and objectives as well as developing effective strategies to achieve them. We are thankful to Carilion Clinic, Pittsylvania County Community Action (PCCA), Lynchburg Community Action (LynCAG), Project Discovery (via James Madison University) and the Virginia Department of Health for their cooperation.

STEP's survey of adult community members focused on those with low-incomes, and is the cornerstone of this needs assessment and gap analysis. This was the optimal means of obtaining feedback from a broad range of people in STEP's service areas (regardless of whether or not they were utilizing STEP programs and services). It is important to again point out that STEP's primary service area encompasses Franklin and Patrick counties. However, Martinsville and Henry County were also included due to the increasing frequency of STEP services being delivered in those areas. The latter was accomplished with the advance knowledge and permission of PCCA, which is the designated Community Action Agency for that area.

Greatest Areas of Need (summary)

Based on the community needs assessment process, following are the greatest needs in STEP's service areas. Collectively, the absence or inadequacy of these resources form the basis or root causes of poverty in STEP's service area.

1. Affordable Health Care

• More physicians, affordable care and medications, mental health and substance abuse services, dental services, healthy living education

1. Transportation

• Community-based transportation initiatives, public transportation, medical, employment and critical need transportation, services in rural areas

2. Employment

• Hard and soft skill training, living wage

3. Affordable Housing

• Safe, affordable, energy efficient, accessible and age appropriate housing. Housing assistance, homeless & homeless prevention services, weatherization, resources for veterans and returning citizens

4. Education/youth services

 High school (graduation) and post-secondary education (access), knowledge of available resources, financial literacy, college/trade school access, after school and summer, teen pregnancy awareness/education

5. Child Care

• Early Head Start program in Henry County, after school and summer programs, services for disabled children, prenatal care

6. Food Security

- 3. Transportation
- 4. Education/youth services

The needs that STEP has identified are consistent with the conclusions of the needs assessments of neighboring colleagues indicating that these need are at least regional. The most common threads include healthcare, education, housing and transportation.
